

PROCEEDING OF THE FIRST MEETING/ OATH TAKING OF NEWLY ELECTED MEMBERS OF SABROOM NAGAR PANCHAYAT HELD ON, 21-12-2015 AT 2 PM AT DAKSHINI(NEW TOWN HALL) SABROOM , SOUTH TRIPURA

1. In pursuance of Message vide No.F.24(21)-UDD/DUD/2010/8732-75 dated 11/12/2015 issued by the Deputy Director, Urban Development, Government of Tripura & subsequent authorization Memo of DM & Collector, South Tripura vide No- F.35(23-DMEO/S/MUNC/2015/501 Dt-12 th December 2015, I, Sri S.C. Saha, Sub-Divisional Magistrate, Sabroom, South Tripura have called the **first meeting** of the newly elected members of Sabroom Nagar Panchayat at Dakshini (New Town Hall, Sabroom) today on 21st December, 2015 at about 2.00 P.M, and presided over the meeting and administered **OATH** or affirmation of the elected members allegiance to the **Constitution of India** before me.
2. Having been completed administering the aforesaid oath, I have conducted the first meeting atPM today in a separate room in & called upon the members present at Dakshini (New Town Hall, Sabroom) to propose the name of the candidate for election of the Chairperson, Sabroom Nagar Panchayat in which the Office of the Chairperson is reserved for SC (Women), who shall assume office forthwith after taking oath or affirmation of allegiance to the constitution of India forthwith.
3. The following directly elected members were present in the meeting -

4. I have explained the procedures of the said election of Chairperson to the elected members present.
5. One **Sri Umakanta biswas** member of the said Nagar Panchayat, has proposed the name of one candidate **Smti Ruma Majumder Basak** for being elected as the Chairperson who was present in the meeting.
6. I have examined to the effect that (i) the proposed candidate is a directly elected member of the said Nagar Panchayat, (ii) the proposed candidate has furnished in writing a declaration in the prescribed form (**Form-3**), as required as per provisions laid down in Rule – 8 of the Tripura Municipal (Election of office Bearers) Rule,1995 and (iii) reservation status of the elected candidate as Notified by the Government is **SC (Woman)**
7. The proposed candidate is found eligible for contesting election of Chairperson
8. I therefore have recorded the name of the proposed candidate with his /her party affiliation together with the name of the proposer and his /her party affiliation in **Form-5**.
9. As no other candidate has been proposed by any other member for election of the Chairperson and the name proposed is found eligible, I, on making entries in the **Form-6** have declared **Smti Ruma Majumder (basak)** as duly elected Chairperson of Sabroom Nagar Panchayat and announced the result of election as uncontested.
10. After that, The Chairperson nominated **Sri Mahitosh Chakraborty** as Vice Chairperson as per provision of Sub-Section-2 of Section 23 of the Tripura Municipal Act,1994.
11. After this the newly elected Chairperson **Smti Ruma Majumder (Basak)** has been administered **OATH** or affirmation to the **Constitution of India** , as per provision of Rule-13(1) of the Tripura Municipal (Election of office Bearers) Rule,1995.
12. Thereafter, **Sri Mahitosh Chakraborty** , the newly elected vice-chairperson has been administered the oath of secrecy as per provision of 13A(4) of the Tripura Municipal (Election of office Bearers 3rd Amendment) Rule,2015.
13. The schedule of activities of oath taking / first meeting of the Sabroom Nagar Panchayat has come to an end at 3.00 P.M. with vote of thanks to all.
